ACCC, ASCO, and National Legislative & Regulatory Issues

ASCO continues to work towards ensuring that people with cancer have access to quality cancer care in the community. Here are some of their current activities with respect to the Medicare Prescription Drug, Improvement, and Modernization Act of 2003 (DIMA):

• CMS Administrator Mark McClellan, M.D., Ph.D., met with the ASCO Board and Committee Chairs to discuss ASCO's

- priorities related to Medicare reimbursement and coverage policy at ASCO's 40th Annual Meeting and indicated a desire to work with oncologists to look at more efficient and effective ways to make coverage decisions, as well as address any access issues that may arise as a result of DIMA.
- DIMA was the focus of a special session at the *Annual Meeting* led by Joseph S. Bailes, M.D., co-*Chair* of ASCO's newly formed *Government Relations Council*, and ASCO *Counsel* Terry Coleman. The session provided a detailed perspective of all the factors affecting the future of changes to DIMA and how ASCO's extensive outreach on *Capitol Hill* is being supported with a media and grassroots action plan launching this summer in key regions.
- ASCO's *Public Service Award*, given at the *Annual Meeting* to individuals who through their advocacy at the national and community levels have increased public awareness about cancer and have had a positive impact on cancer-related policies and programs, was awarded this year to *Representatives* Charlie Norwood (R-GA) and Lois Capps (D-CA) in recognition of their extraordinary efforts to promote legislative solutions to preserve high-quality cancer care.

The ASCO Clinical Practice Committee (CPC) met on Monday, June 7th. Peter Paul Yu, M.D., ANCO President, John A. Keech, Jr., D.O., Chair, ASCO CPC, and Peter D. Eisenberg, M.D., represented ANCO at this meeting. Among the items discussed were:

- A Government Relations Council, co-Chaired by Dave Johnson, M.D., incoming ASCO President and Joseph S. Bailes, M.D, will lead ASCO's legislative/regulatory advocacy efforts.
- ASCO's legislative/regulatory priority is to obtain a freeze on administration payments while awaiting the MedPAC study on the impact of the DIMA. *Congress* will recess in late June

- and early July. Members are encouraged to meet with their *Congressional* representatives at this time to inform them of DIMA's impact on their oncology practices and constituents in 2005. Representatives should be asked to request that CMS release ASP data as soon as possible. Please contact ASCO at grassroots@asco.org or (703) 299-1050 if you plan on meeting with your *Congressional* representatives as they can help you plan and prepare for the meeting.
- The state/regional affiliates (state societies) and community oncologists are ASCO's number one priority in the new strategic plan. Look for additional *Best of ASCO* programs, a new edition of *Practical Tips for the Practicing Oncologist* (to be published in 2004 and e-updated regularly), a practice management newsletter and educational series, and initiatives to integrate quality measures and information technology into the practice setting. Additional practice management services will be developed and delivered.
- The American Medical Association's (AMA) Relative Value Update Committee (RUC) is focusing on the DIMA mandated reevaluation of infusion codes and the American Society of Hematology (ASH) and ASCO are working together to obtain a permanent seat on the RUC.
- ASCO will present several new oncology codes for consideration by the *AMA CPT Advisory Committee*, including multiple drug infusion codes, a new code for the administration of monoclonal antibodies, allowing use of 96530 for port flushes, an emergency management code, and a chemotherapy management code.
- ASCO and the Administrators in Oncology/Hematology Assembly (AOHA) are completing a service line survey of oncology practices to help identify and quantify all the elements of oncology

- practice. Survey results will help define and value new code proposals.
- CMS has issued new regulations for incident to services. If different, then the ordering physician must be identified and the supervising physician's PIN and signature must be used to submit the claim. Associate each physician to the services claimed.
- CMS has issued new regulations with regard to **physician self-referral**. First, writing a prescription does not constitute a referral to the drug's manufacturer, even if the prescribing physician serves as a consultant to the manufacturer. Second, physician compensation can be based on chemotherapy administration services. However, while ASCO believes that compensation can also be based on the amount of drugs ordered, the CMS regulations remain ambiguous.
- CMS is considering differential reimbursement based on quality of care (i.e., pay for performance). ASCO's quality initiatives are, therefore, extremely relevant. CMS is also considering disease management systems.
- AMA and CMS are discussing repairs to the combined payment system for skilled nursing facilities (SNFs).
- CMS is struggling with DIMA's competitive acquisition provisions and asking for guidance from physicians on how drugs are currently ordered, acquired, inventoried, stored, etc. In addition, questions regarding the handling of patient copays, wastage, returned drugs, and patient insurance data remain.
- Patients should (and their providers should encourage them to) call 1-800 Medicare to report access to care problems.
- ASCO's *Health Services Committee* will continue to develop practice guidelines, but release them in new formats that are of more utility for the practicing oncologist. They will also

- develop tools to assess what guidelines are being used and by whom. Finally, they will also focus on ways to implement the findings of ASCO's *National Initiative on Cancer Care Quality* (NICCQ), especially ways of improving documentation of cancer care.
- ASCO's *Public Issues Committee* will focus on broad public health and cancer issues, especially cancer care workforce issues.
- ASCO's *Career Development Committee* is assessing how changes in the current practice environment are impacting young physician decisions to enter clinical practice.
- Patient advocacy groups, led by the National Coalition for Cancer Survivorship (NCCS) is working within the Cancer Leadership Council and the state/regional affiliates to appropriately mobilize patients with respect to DIMA.

ASCO, in collaboration with the *Oncology Nursing Society* (ONS), has developed a new workshop designed to increase accrual to clinical trials by instructing community oncologists about the integration of clinical trials into their practices. *Clinical Trials for Workshop for the Community Oncology Team* will take place in Dallas on October 15-17th. Attendance is limited to 100 participants. Applications for attendance may be downloaded from www.asco.org (meetings and education) and must be submitted electronically by Tuesday, June 15th. CMA, MOASC, and State Legislative/Regulatory Issues

ANCO and MOASC cooperate on several joint ventures and coordinate activities in the advocacy and membership benefit arenas. Each is represented at the Board meeting of the other.]

ANCO has joined other specialty societies and the CMA in supporting the campaign to affirm the *Health Insurance Act* (SB2) and opposing attempts to repeal this law on the

November 2004 ballot. When fully implemented, SB2 would provide health and financial security to millions of Californians that now get coverage through their employer, expand coverage to another one million Californians, and ensure fairness to employers who provide such benefits but have to compete against those large employers that do not.

ANCO is cooperating with CMA in its survey of physician practice costs. The survey process runs from June 1st through July 15th. You can participate in the survey by visiting www.zoomerang.com/recipient/survey-intro.zgi?p=WEB2J8MQRUTQ.
